C I R C U L A R

The Directorate of Tribal Welfare is implementing “Scheme of Scholarship to ST students pursuing Home Nursing Courses”. The Objective of the Scheme is to provide financial assistance to the poor and meritorious students belonging to Scheduled Tribe in order to enable them to pursue Home Nursing courses.

In this regards applications are invited from eligible students for the academic year 2022-23.

Criteria of the Scheme is as under:-

1. Students belonging to ST Communities, who gets admission in an institution recognized by the State/Central Government to pursue above mentioned Home Nursing courses, shall be eligible for the Scholarship. The Scholarship shall be awarded to the regular student who is born in Goa and domiciled in Goa for at least 15 years.
2. The annual income of the parent or guardian of the student shall not exceed Rs. 6.00 lakh from all sources.

Required Documents are as under:-

1. Passport Size Photograph.
2. Attested copies of Certificate of educational qualifications.
3. Copy of ration card.
4. Copy of Caste Certificate issued by Competent Authority.
5. Copy of Income Certificate issued by Competent Authority.
6. Receipt of Fees paid.
7. Copy of Birth Certificate.
8. Copy of Domiciled Certificate or Residence Certificate.
9. Copy of Bank pass Book.
10. Copy of Aadhaar card along with Consent form.

Application under the said scheme shall be submitted through the Principal of the Institute in which student is studying in the prescribed application form.

Eligible students shall submit duly filled application form with required documents to the Institute and after the verification Institute shall submit application forms of the student along with covering letter to this Directorate.

Application forms under Home Nursing Scheme are available in this Directorate as well as in the Dy. Director Tribal Welfare, Margao – Goa office, or can be obtained from the official Website of Tribal Welfare Department. Website: tribalwelfare.goa.gov.in Email: dir-tw.goa@nic.in


Institutions under jurisdiction of North Goa District shall submit applications to the Directorate of Tribal Welfare, Shram Shakti Bhavan, 5th floor, Patto, Panaji – Goa and Institutions under Jurisdiction of South Goa District Shall Submit applications to the office of the Dy. Director of Tribal Welfare, 2nd floor, A wing, Old Collectorate building, Margao, Salcete – Goa, during office hours.

It may be noted that the last date of submission of forms/applications of Home Nursing Scheme is 30th November, 2022.

The Circular may be brought to the notice of the student eligible for scheme.
